All dogs will receive a monthly flea/tick and heartworm preventative which will be provided by handler, and will appear on your statement monthly.

Please attach a copy of your dog's rabies certificate. It is required by law to accompany your dog during any public event. (Whether dog is traveling with handler or is met ringside). **Your signature below is also an authorization for any emergency care needed and/or provided while in care of the handler. All veterinary fees will be the responsibility of the owner.** All dogs must be kept current on all vaccinations. Bordetella vaccination is required every 6 months. It is the responsibility of the owner to inform us when vaccinations are due. All dogs are required to be on heartworm preventative and checked yearly while in our care. Owner is responsible for any life/health insurance placed on dog.

Duties of Handler

The handler agrees to present your dog(s) in a professional manner, with both handler and dog well groomed and enthusiastic. The handler agrees to abide by the rules of the AKC and local kennel and breed

clubs. The handler agrees to exercise and provide quality care and housing, to keep kennel premises sanitary and properly enclosed. Also to keep your dog safe, properly fed, and housed in a sanitary atmosphere. The handler will provide a safe travel environment with soft bedding, temperature controls and alarms. Our priority dogs are the dogs traveling with the handler, and take priority over ringside dogs. We hope that you will trust us on making the right decision to make your dog look and show it's best.

Liabilities Excluded

The above dog is boarded, trained, or otherwise cared for by the handler without liability for the following: Loss or damage from disease, bloat, death, theft (while being housed or transported), injury to a person, injury to or from other dogs, destruction of property, or other unavoidable causes.

FEES: The undersigned owner or responsible party agrees to pay the handler as set forth in the enclosed schedule of fees. It is also agreed that the understood owner or responsible party will pay all entry and veterinarian fees. There will be a fee charged weekly for bathing and grooming depending on the coat and condition of the individual dog. A \$500.00 deposit per dog is required for all dogs boarding and traveling with the handler. This will be credited to use on your final bill. A statement will be mailed monthly along with itemized weekly invoices. All statements are due within 30 days of billing. Weekly results can be accessed online. A monthly late fee will be charged on payments received after the 25th of the month. There will be an 18% APR applied to all invoices carrying a balance after 60 days, with the interest rate accruing from date of original invoice. Payment is due in full when picking up your dog. Payment options are as follows: cash, money orders, personal checks, debit cards, Visa, Mastercard, Discover, and American Express.

Photographs: All major wins, exceptional breed wins, group placements, Best in Show, Specialty, and National wins will get pictures taken unless the owner specifies otherwise. The owner will be responsible for the cost of all photographs. The handler will receive at least one photo, of her choice, of any championship title she completes at no charge. The owner is required to run one advertisement in a magazine of the owner's choice during or after the championship is accomplished, listing Linda Clark as handler.

Cancellations: The owner must cancel all entries before the close of the show. Handling fees will be invoiced unless the handler withdraws the entry before it closes. There is a \$4.00 Charge (plus entry fee) for each entry made by handler. If a dog finishes its championship during a series of shows already contracted, the handler may show the dog as a special for the same fee. If a conflict should arise your dog will be placed with her assistant or another experienced handler and normal fees will apply.
