***Terms of Contract***

- 1) A minimum deposit of \$500.00 per pet is mandatory for all clients. The deposit will be held in escrow until the final bill, where it will be credited towards the final payment.
- 2) Owner will be responsible for all handling fees, travel expenses, mileage, and entry fees for any given shown unless cancellation is made prior to the closing dates of the show.
- 3) The undersigned owner and/or responsible party agree to pay the handler all fees as set forth in the scheduled fees. It is further agreed and understood that the undersigned owner and/or responsible party will be responsible for all fees agreed upon and understands that amounts incurred under this contract will be due according to the terms outlined in the following:

Payments will be considered delinquent after an unpaid term of 30 days. A monthly late fee of \$5.00 will be charged on payments received after the 25<sup>th</sup> of the month. After a period of 90 days without payment, the entire balance will become due. There will be an 18% APR applied to all invoices carrying a balance after 60 days, with the interest rate accruing from date of original invoice. Payments will be made in full on monthly basis. Monthly statements will be mailed around the 5<sup>th</sup> of the month.

Please note: If we do not receive a monthly payment on this account and the balance exceeds \$1,000.00 your dog will not be entered in any more shows until half of the outstanding balance has been paid. Payment is due in full when picking up your dog. Payment options available are as follows: cash, money orders, personal checks, debit cards, Visa, MasterCard, Discover, and American Express.
